#### 1. Opening Prayer

Chair Jordan Coble led the Council in an opening prayer to begin the meeting in a good way.

#### 2. Welcome

Chair Coble welcomed everyone to the IEC meeting and expressed the importance of the Council working together in the budgeting process with open hearts and open minds.

#### 3.1 Adoption of the February 4, 2025 Agenda

#### 4. **NEW BUSINESS**

#### 4.1 2025/2026 Draft Indigenous Education Program Preliminary Budget

Jesse Bruce, Director of Instruction – Indigenous Education and Equity, reminded the IEC that reviewing the preliminary Indigenous Education budget is a confidential process and that discussion of the proposed expenses must remain at the IEC table.

Delta Carmichael, Secretary-Treasurer/CFO, presented the draft 2025/2026 Indigenous Education Program Preliminary Budget. The expenses within the budget are grouped into four main categories: Cultural and Language Expenses, General Staffing Expenses, General Program Expenses, and Expenses to be Recovered from District. The draft 2025-2026 Indigenous Education Program Preliminary Budget is based on an estimated FTE of 3,110 Indigenous students and a 3% increase in per pupil funding to \$1,823. The per pupil funding will be adjusted after the Ministry of Education and Child Care announces the 2025-2026 per pupil funding at spring break. The number of enrolled Indigenous students will be adjusted at the end of September 2025 when the District reports actual student enrolment to the Ministry. The Indigenous Education Program money left unspent from the 2024-2025 school year will become the Estimated Previous Year Surplus in the 2025-2026 budget and is projected to be approximately \$50,000, down from over \$561,000 the previous year. The District anticipates the total Targeted Funding for the preliminary 2025-2026 Indigenous Education Program budget to be approximately \$5.7 million.

1:55 pm – Elder Barnes joined the meeting via Zoom.

The Secretary-Treasurer/CFO and the Director of Instruction – Indigenous Education and Equity outlined the proposed 2025-2026 budgeted allocation decreases, to balance the budget pressure, and engaged in discussion with the Council regarding the rationale behind the following:

- Remove Indigenous Cultural Presenters (2.0 FTE)
- Reduce Cultural Program/Presentation and Supplies
- Reduce Indigenous Student Advocates (3.6 FTE)
- Reduce Clerical Support (0.17 FTE)
- Reduce Middle School Indigenous Success Teacher (0.3 FTE)
- Reduce Early Learning Teacher Consultants (1.0 FTE)
- Minor reductions in various General Program expenses

The IEC members discussed the draft 2025/2026 Indigenous Education Program Preliminary Budget, expressing concern regarding the removal of the District's Indigenous Cultural Presenters and the reduction in allocation for Indigenous Student Advocates. The IEC spoke about the need to set parameters over rates paid to external presenters for workshops; the desire for beyond-the-school-bell programming for Indigenous students after school and during spring, summer and winter break; a Junior Advocate Program; and, creating a Reconciliation Coordinator position in the future.

3:00 pm - The Superintendent of Schools/CEO left the meeting.

The Secretary-Treasurer/CFO shared that the Feeding Futures Fund, a grant from the Ministry of Education and Child Care, continues to supplement the Indigenous Education Budget with \$100,000 for the 2025-2026 school year.

Chair Coble thanked the Secretary-Treasurer/CFO and the District staff for drafting the 2025-2026 Indigenous Education Program Preliminary Budget and encouraged the IEC to have faith in the process, in the way incremental shifts are made and in the way services are delivered to the students. He reminded the Council that emphasis should be on the children, to stay connected with the learners, that they are in the middle, and that we must help each other walk hand in hand so we can make the changes. The Chair expressed appreciation for the willingness of the District staff to facilitate change and take on the challenge.

- Lake Country Native Association (LCNA) is hosting a Youth Drumming Circle on February 9th, with Elder Randy Swanson. LCNA is succession planning and mentoring someone to continue the work of the association. In January, fifty people attended the monthly LCNA Family Gathering in Lake Country.
- Ki-Low-Na Friendship Society recently held a cold weather clothing drive in conjunction with a local radio station.
